- 4) Use of Name and Media Releases. Use of Name and Media Releases. Coloplast and the Receiver agree to cooperate in promoting the relationship to raise awareness of the Sponsorship. However, neither Party shall disclose the terms of this Agreement or use the name, logo, trademark, or service mark in any promotional or general announcement, media release, or public statement without the other Party's prior written approval.
- 5) <u>Danish Executive Order on Advertising</u>: The Organisation shall be fully liable for fulfilling its legal obligation to publish information about the received Sponsorship on its website, cf. the Danish Executive Order on Advertising, paragraph 20.
- 6) <u>Governin al w ven e</u>, in the event of any controversy arising out of or relating to any provision under this Agreement, the Parties shall try to settle the problem amicably between them. Should they fail to agree, all matters arising out of or in connection with this Agreement shall be finally settled by the civil courts in Denmark. This Agreement shall be construed and interpreted pursuant to Danish law. without reference to conflict of laws principles.
