

- 1) The sponsorship is made for this specific purpose only, and no other use of the Sponsorship is permitted.
- 2) Payment Information. Coloplast will transfer the Sponsorship within 10 business days from signing this Agreement to the bank account designated by the Organization and as specified in Exhibit A.
- 3) No Services. Coloplast and the Organization agree that no services, sale, promotion, or similar activity is indicated or agreed through this Sponsorship. The parties further agree that the Sponsorship is not intended as a price concession, reward to favoured customers or as an inducement to purchase, lease, recommend, prescribe, use, supply or procure Coloplast' products or services.
- 4) Use of Name and Media Releases. If especially agreed, Coloplast and the Organization agrees to cooperate in promoting their relationship to raise awareness of the Sponsorship. However, neither Party shall be allowed to disclose the terms of this Agreement or to use the name, logo, trademark, or service mark of the other Party in any promotional or general announcement, media release, or public statement without the other Party's prior written approval.
- 5) Danish Executive Order on Advertising: The Organization shall be fully liable for fulfilling its legal obligation to publish information about the received Sponsorship on its website, cf. the Danish Executive Order on Advertising, section 20.
- 6) Signature: This Agreement may be signed in any manner that clearly evidences the Parties' intent to be bound, including via electronic, or digital signatures and may be executed in one or more counterparts, each of which shall be an original and which together, when executed, shall be one and the same instrument having the same effect as if each Party had executed the same document.
